Guidelines for Proposal Submission

Steps in Submitting a Proposal

Session Proposal Form: Complete the N4A Region II Workshop Submission Form.

Abstract: Please type presentation objectives, content, and outline in a 250-word (maximum) **abstract** on a **separate page**. This is a blind page and should NOT include the names of presenters.

Presenter Bios: Please include a short bio on each presenter. In the bio, please include education, work history, expertise, publications, specializations, and certifications. Bio should be limited to 200 words.

Responsibilities of Presenters

- All presenters must have expertise in their session topic.
- All presenters **must register** and **pay fees** for the conference. N4A is unable to reimburse program participants for expenses.
- If all session presenters are not registered, the session will be cancelled.
- When two or more people are presenting, the Contact Presenter is responsible for notifying all co-presenters about the status of the proposal.
- Sessions selected for the conference should not have the content significantly changed once the proposal is accepted.
- Presenters are responsible for providing session handouts (Please have at least 25-30 handouts for your session—more information will be provided as the conference date closes per conference attendees).
